Director Vejraska, with a second from **Director Alms**, made a motion to adjourn the meeting.

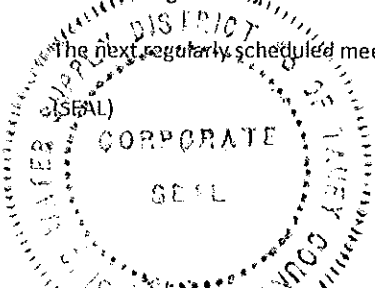

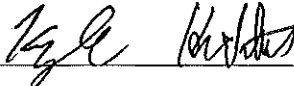

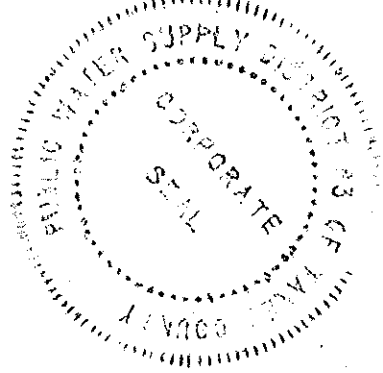
